WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot Number 4 on plat of Maple Acres Subdivision, prepared by C.O. Riddle, dated June 1953 and recorded in Plat Book FF at Page 111 of the RMC Office for Greenville County; said lot having a depth of 130.9 feet on the south side, a depth of 125.4 feet on the north side, a rear width of 211.9 feet and a frontage of 165.9 feet on the northwest side of Chastain Drive.
