NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of and other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, S.C.

All that lot of land with the buildings and improvements thereon, situated on the Northern side of James Drive near the City of Greenville, in Greenville County, South Carolina being shown as lot No. 12 on a plat of Orderest Park, made by C.C. Jones, engineer, July, 1948, recorded in the R.M.C. office for Greenville County, South Carolina in Plat Book S at page 109 and having, according to said plat, the following metes and bounds, to-wit: BEGINNING at an iron pin on the North side of James Drive, the front joint corners of Lots Nos. 11 and 12 and running thence with the joint lot of said lots N. 8-16 W. 160 feet to an iron pin; thence running S. 81-44 W. 60 feet to an iron pin on the East side of a 20 foot alley; thence with the Eastern side of said alley S. 8-16 E. 160 feet to an iron pin on the Northern side of James Drive; thence with Northern side of said street North. 81-44 E. 60 FEET to the point of BEGINNING.

Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
