(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of **Twenty-Nine Thousand and No/100ths**-----DOLLARS

(\$ 29,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is **fifteen** years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, shown and designated as Lot No. 138 on plat of Kingsgate, Section 2, prepared by Piedmont Engineers and Architects, dated October 13, 1973, revised December 27, 1973 and January 4, 1974, recorded in Plat Book 5D at Page 23 and being described, according to said plat, more particularly, to-wit:

BEGINNING at an iron pin on the northern side of Swindon Circle at the joint front corner of Lots 137 and 138 and running thence along said circle S. 58-00 W. 70 feet to an iron pin; thence S. 61-00 W. 40 feet to an iron pin; thence S. 69-00 W. 15 feet to an iron pin at the joint front corner of Lots 138 and 139; thence along the common line of said lots N. 22-13 W. 150.4 feet to an iron pin at the joint rear corner of said lots; thence N. 64-13 E. 22 feet to an iron pin; thence N. 58-15 E. 76.95 feet to an iron pin at the joint rear corner of Lots 137 and 138; thence along the common line of said lots S. 32-00 E. 150.5 feet to an iron pin at the joint front corner of said lots, the point of beginning.
