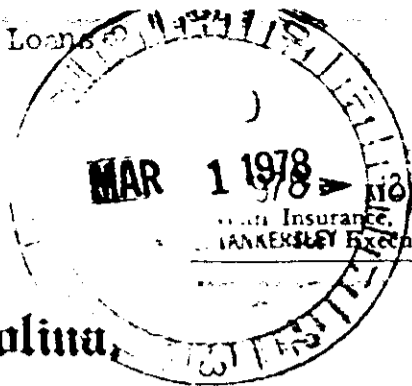

Butler in consideration of the said debt, and for the better securing the payment thereof, according to the conditions of the said Note; which with all its provisions is hereby made a part hereof; and also in consideration of Three Dollars to the said mortgagor in hand well and truly paid, by the said mortgagee, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Liberty Loans Corp. d/b/a Domestic Loans.

All that piece, parcel or lot of land in the County of Greenville, State of South Carolina, situate, lying and being on the northeastern side of Chesley Drive and being known and designated as Lot No. 65 on the plat of The Village Subdivision, Section I, plat of which is recorded in the REC Office for Greenville County in Plat Book 4-R at Page 52, and having such metes and bounds as shown thereon, reference to said plat being made for a more complete description.

Beginning at an iron pin on the northern side of Chesley Drive at the joint front corner of Lots Nos. 65 and 66 and running thence with the line of Lot No. 66 N. 23-46-02 E. 156.75 feet to an iron pin; thence with the line of Lot No. 54 S. 54-53-45 E. 95 feet to an iron pin at the joint rear corner of Lots Nos. 64 S. 31-34-00 W. 135.75 feet to an iron pin on the northern side of Chesley Drive; thence with the curve of the northern side of Chesley Drive, the chord of which is N. 61-19-17 W. 75 feet to the point of Beginning.
