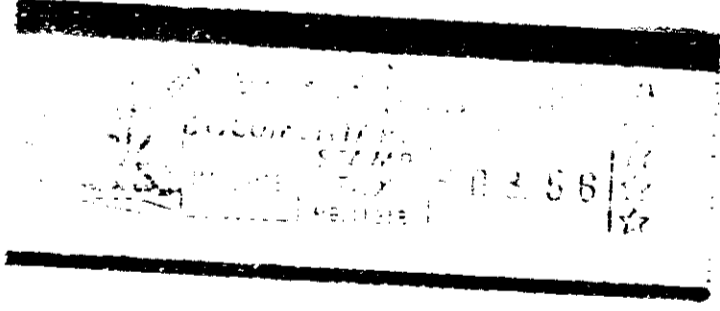
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, the Mortgagee's heirs, successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, known and designated as Lot No. 6 shown on a plat of the subdivision of Vista Hills, recorded in the RMC Office for Greenville County in plat book P at page 39, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the eastern side of Ridgecrest Drive at the intersection of Wellington Avenue; thence with Ridgecrest Drive, N. 30-58 E. 75 feet to an iron pin; thence S. 59-46 E. 223 feet to an iron pin on a county road; thence with said county road, S. 26-51 W. 79.7 feet to an iron pin; thence S. 44-32 W. 85 feet to an iron pin at the intersection of said county road and Wellington Avenue; thence with Wellington Avenue, N. 37-01 W. 225 feet to the beginning corner.
