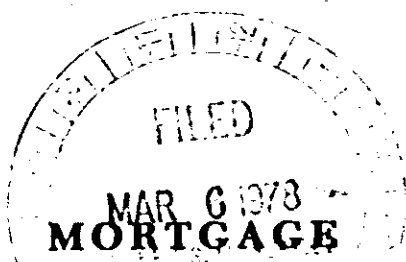

TO ALL WHOM THESE PRESENTS MAY CONCERN: Charles G. McCuen and Valerie D. McCuen

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Seven Thousand, nine hundred and sixty-two Dollars and 00/100----- DOLLARS

(\$ 7,962.99), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 5 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southerly side of Oakleaf Drive, near the city of Greenville, and being designated as Lot No. 43 on plat entitled "Edwards Forest Heights", as recorded in the R.M.C. Office for Greenville County, South Carolina, in plat Book 000, at page 87; and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Oakleaf Drive, the joint front corner of Lots 42 and 43; and running thence along the common line of said lots S. 1-29 E. 160 feet to an iron pin, in the rear line of Lot 45; thence along the rear line of said lots S. 88-31 W. 110 feet to an iron pin, the joint rear corner of Lots 43 and 44; thence along the common line of said lots N. 1-29 W. 160 feet to an iron pin on the southerly side of Oakleaf Drive; thence along said Drive N. 88-31 E. 110 feet to an iron pin, the point of Beginning.
