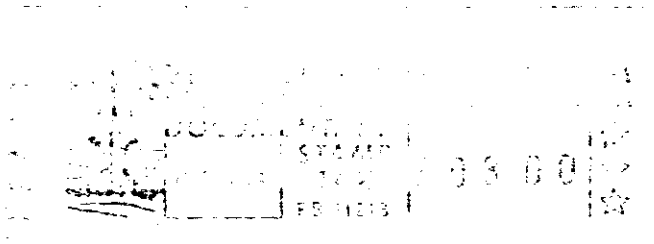

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the town of Mauldin, being known and designated as Lot No. 53 on plat of Windsor Park Subdivision, recorded in Plat Book RR at page 25, in the RMC Office for Greenville County, South Carolina, and having, according to said plat, the following metes and bounds, to-wit:
