"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the Town of Simpson-ville, and being shown and designated as Lot 18 on a plat of Martindale Subdivision recorded in the RMC Office for Greenville County in Plat Book BBB at page 97 and having, according to said plat, the following metes and bounds, to-wit:
