gagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the
receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does
grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real
estate situated in the County of **Greenville, Town of Mauldin,**
State of South Carolina: being known and designated as Lot No. 45 on a plat of Holly Springs,
Section I recorded in the R.M.C. Office for Greenville County in Plat Book 4N, Page 5 and
also shown on a plat entitled Property of Michael D. Underwood and Deborah E. Underwood
prepared by Freeland & Associates on March 16, 1978, and recorded in the R.M.C. Office

and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in
connection with the real estate herein described.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple ab-
