TO ALL WHOM THESE PRESENTS MAY CONCERN: Jimmy E. Miller and Jane G. Miller

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-seven Thousand One Hundred Fifty and 00/100-----DOLLARS

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, and more fully described by the following metes and bounds as surveyed by J.E. Rosamond in Jan. 1950; and as shown by the plat made of said property.

BEGINNING at an iron pin on the county road known as the Batson Rd. and running thence S. 49 W. 365.0 feet to an iron pin, thence S. 39-15 E. 100.0 feet along the rear side of this property to an iron pin, thence S. 52-45 E. along the rear side and a distance of 150.0 feet to an iron pin, thence N. 39-15 E. 439.0 feet to an iron pin on the above described county road, thence N. 71-15 W. 185.0 feet along the county road to the beginning corner, containing two acres, more or less, and being the same property described in a deed from Louis C.
