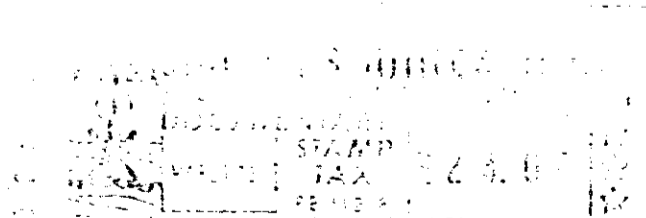

Highway 14, running thence with the western side of said Highway, N. 02-50-22 E. 160 feet to an iron pin, running thence S. 77-50-22 W. 100 feet to an iron pin, running thence S. 30-50-22 E. 127.06 feet to an iron pin at the joint rear corner of Lots Nos. 76 and 77, thence with the joint line of said lots S. 60-42-59 E. 126.26 feet to point of beginning.
