WHEREAS, the Mortgagor is well and truly indebted unto Associates Financial Services Co. Inc.

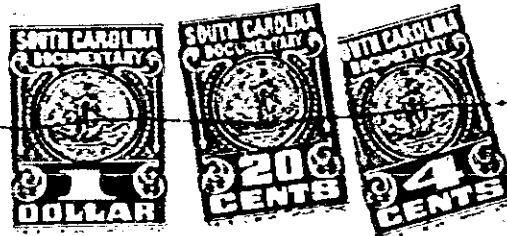
