(\$ 90,000), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee, on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, 1 ying and being in Chick Springs Township, on the northeastern side of Brushy Creek Road also known as Taylors Road and being known and designated as Tract No. 1 on plat of Property of N.C. Boling Estate recorded in the R'M.C. Office for Greenville County in Plat Book H at page 223 and having, according to said plat, the following metes and bounds, to-wit: BEGINNING at a point in the center of Brushy Creek at the joint corner of Tracts Nos. 1 and 2 and running thence along the center of said Road N. 31-3/4 W. 3.08 chains to a pin in the center of said Road; thence 45-3/4 E. 8.69 chains to an iron pin; thence N. 49-1/4 E. 3.71 chains to an iron pin; thence along the joint line of Tracts No. 1 and 6 S. 41-1/4 E. 3 chains to an iron pin at the joint rear corner of Tracts No. 1 and 2; thence along the joint line of said lots S. 46-3/4 W. 13.50 chains to the point of beginning, the containing 4.01 acres, more or less. If at any time the Local Board of Trustees shall cease to exist or of operform its duties, then the State Overseer of the State in which said real estate is located shall have the power to declare all offices on the said board Tyacant and the State Board of Trustees of the Church of God for that state shall Nausomatically then hold title. Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
