Juanita M. Perdue (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Sixteen Thousand and 00/100-----DOLLARS

(\$ 16,000.00) as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 20 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the southern side of Gallivan Avenue, and being known and designated as Lot No. 47 and a portion of Lot No. 46 of North Hills, as shown on plat thereof recorded in the RMC Office for Greenville County in Plat Book H at Page 138, and having, according to a more recent survey prepared by Dalton & Neves, April, 1960, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Gallivan Avenue at the joint front corner of Lots 47 and 48, and running thence along the joint line of said Lots, S. 19-17 W. 162.4 feet to an iron pin; thence S. 69-23 E. 103.62 feet to an iron pin; thence N. 19-17 E. 166.4 feet to an iron pin on the southern side of Gallivan Avenue; thence along the southern side of said Avenue, N. 71-43 W. 103.5 feet to the point of beginning.

ALSO: All that piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, on the southern side of Gallivan Avenue, and being the western one-half (1/2) of Lot No. 46 of North Hills, as shown on plat thereof recorded in the RMC Office for Greenville County in Plat Book H at Page 138, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Gallivan Avenue at the joint front corner of Lots 46 and 47, and running thence along the joint line of said Lots, S. 19-17 W. 165 feet to an iron pin at the joint rear corner of said Lots; thence S. 69-23 E. 34.53 feet to a point in the center of the rear line of Lot 46; thence through the center of said Lot, N. 19-17 E. 166.4 feet to an iron pin on the southern side of Gallivan Avenue; thence along said Avenue, N. 71-43 W. 34.5 feet to the point of beginning.
