All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 80 as shown on plat of DEVENGER PLACE, Section No. 3, recorded in plat book 5 P page 99 of the RMC Office for Greenville County, S. C., and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the south side of Hedgewood Terrace, the joint front corner of Lots 79 & 80, and running thence with the joint line of said lots S. 4-18 W. 150 feet to an iron pin in line of property of Estate of F.
