NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as Lot 59 on plat of Chestnut Hills No. 1, recorded in Plat Book QQ at page 83 and having the following courses and distances: BEGINNING at an iron pin on Kathryan Court, joint front corner of Lots 58 and 59 and running thence N. 14-04 E. 191 feet to an iron pin, joint rear corner of said lots; thence along the rear line of Lot 59, S. 44-52 E. 50.7 feet and S. 48-34 E. 56 feet to an iron pin, joint rear corner of Lots 59 and 60; thence along the joint line of Lots 59 and 60, S. 19-20 W. 141.8 feet to an iron pin on Kathryan Court; thence N. 73-56 W. 80 feet to the point of beginning.

In addition to and together with the monthly payments of principal and interest under the terms of the Note secured hereby, the mortgagor promises to pay to the mortgagee a monthly premium necessary to carry private mortgage guaranty insurance until the principal balance reaches 80% of the original sales price or appraisal, whichever is less. The estimated monthly premium for the first nine years will be .02% of the original amount of the loan. The estimated monthly premium for each year the reafter will be .01% of the original principal balance of this loan. The mortgagee may advance this premium and collect it as part of the debt secured by the mortgage if the mortgagor fails to pay it.
