Greenville, South Carolina, hereinafter called the Mortgagor, is indebted to

, a corporation organized and existing under the laws of the State of South Carolina, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Thirty-six thousand five hundred - - - - - Dollars (\$ 36,500.00), with interest from date at the rate of Eight and 3/4ths per centum (8.75%) per annum until paid, said principal and interest being payable at the office of Aiken-Speir, Inc., P. O. Box 391 in Florence, S. C. , or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of Two hundred eighty-seven and 26/100 - - - - - Dollars (\$ 287.26), commencing on the first day of June , 19 78, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of May, 2008 .

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of Greenville State of South Carolina; on the eastern side of Bismarck Drive, being shown and designated as Lot 28 on a Plat of DAKOTA HILLS, Section II, recorded in the RMC Office for Greenville County in Plat Book 5-D, at Page 77. Said Lot fronts an aggregate of 172.9 feet on the eastern side of Bismarck Drive; runs back to a depth of 170.0 feet on its northern boundary; runs back to a depth of 140.0 feet on its southern boundary, and is 160.0 feet across the rear.
