All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot No. 9 on plat of Pride & Patton Land Company, recorded in Plat Book E, at Page 249 in the RMC Office for Greenville County and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Heatherly Drive at the joint front corner of Lots 38 and 39 and running thence with Lot 39, S. 36-15 W. 210.0 feet to pin; thence S. 53-54 E. 50.0 feet to an iron pin at rear corner of Lot 40 thence with Lot 40, N. 36-15 E. 210 feet to an iron pin on Heatherly Drive; thence with the southwestern side of said Drive, N. 53-45 W. 50.0 feet to the point of beginning.
