and Neatia S. Porter (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Beginning at an iron pin 208 feet from the intersection of Tenth Street and Whitmire Street, on the western side of Whitmire Street, and running thence N 76-10 W, 53.6 feet to an iron pin; thence S 10-10 W, 58 feet to an iron pin; thence S 76-103, 53.6 feet to an iron pin in line of Whitmire Street; thence N 10-10 E, 58 feet to the beginning corner, and being a portion of Lots 21 and 23, Block A, City View, as shown on Plat recorded in the RMC Office for Greenville County in Plat Book A, at Page 427.
