TO ALL WHOM THESE PRESENTS MAY CONCERN: CLEM TOMLINSON and BETTY TOMLINSON

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

Nineteen thousand five hundred and No/100ths----- DOLLARS

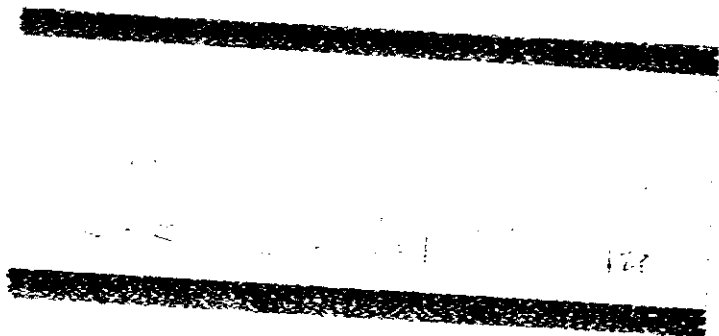
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

\*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southwestern side of Sunset Drive in the City of Greenville, being shown and designated as Lot 86 on Plat 2 of Sunset Hills recorded in Plat Book P at Page 19 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Sunset Drive at the joint front corner of Lots 85 and 86 and running thence with the line of Lot 85, N. 86-41 W. 189.3 feet to pin; thence N. 27-56 E. 153.2 feet to pin at corner of Lot 87; thence with Lot 87, S. 71-34 E, 167 feet to pin on Sunset Drive; thence with the southwestern side of said Drive, S. 18-41 W, 100 feet to the point of beginning.
