TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, Gerald D. Lockhart and Brenda F. Lockhart,

(hereinafter referred to as Mortgagor) is well and truly indebted unto Sharonview Federal Credit Union, Charlotte, North Carolina

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Twenty-Five Thousand and 00/100-----

-----Dollars (\$25,000.00) due and payable in Two Hundred Eighty-Eight (288) semi-monthly installments of One Hundred Forty-Two and 10/100 (\$142.10) Dollars each, the first installment being due April 15, 1978

with interest thereon from date at the rate of 3/4 of per centum per annum to be paid semi-monthly month

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as a 5.0 acre tract on a plat entitled "Balliew Property", said tract lying on the southwesterly side of S. C. Highway 14, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwesterly side of S. C. Highway 14, and running thence with the line of other property of J. L. Balliew, S. 55-09 W. 668.66 feet to an iron pin; thence N. 36-00 W. 128.0 feet to an iron pin; thence N. 18-29 E. 383.91 feet to a point; thence with the property of South Carolina Game & Fish Department, N. 22-26 E. 169.0 feet to an iron pin; thence S. 86-01 E. 301.7 feet to an old iron pin; thence S. 47-13 E. 135.04 feet to an old iron pin on the southwesterly side of S. C. Highway 14; thence with said Highway, S. 16-29 E. 134.69 feet to an iron pin, the point of beginning.
