ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Rockmont Road (formerly Hudson Drive) and being known and designated as Lot No. 20 of Hudson Acres Subdivision, plat of which is recorded in the RMC Office for Greenville County in Plat Book "Y" at Page 30 and having such metes and bounds as shown thereon.

This conveyance is made subject to restrictions, easements and rights-of-way appearing on record in the RMC Office for Greenville County.
