NOW KNOW ALL, MEN, that the mortgagor(s) in consideration of the said debt, and for the better securing the payment thereof, according to the conditions of the said Note; which with all its provisions is hereby made a part hereof; and also in consideration of Three Dallars to the said mortgager in hand well and truly paid, by the said mottgagee, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said mortgages, its (his heirs, successors and assigns forever, the following described real estate:

All those pieces, parcels, or lots of land, lying situate and being in the State of South Carolina, County of Greenville, on the Northern side of East Pendleton Road as shown on plat recorded in Plat Book G at Page 13 as Lots 6, 7, 8, 9, and the rear portion of Lot 12 and when described together having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northern side of East Pendleton Road, corner of Lot 10. and running thence with the line of said lot and extending across Lot 12 in a straight line N. 1 W. 202.8 feet, more or less, to an iron pin in line of Lot 13; thence with the line of said Lot and the rear line of Lot 8 S. 63-35W. 128 feet, more or less, to an iron pin corner of Lot 7; thence with the rear line of Lots 6, and 7 N. 56-25 W. 105.8 feet to corner of Lot 5; thence with the line of said Lot S.3-20 W. 197 feet to an iron pin on East Pendleton Road; thence with the Northern side of East Pendleton Road S. 86-40 E. 215 Feet to the point of BEGINNING.

DERIVATION: Apartment 646, File 28 and Apt. 1186, File 6 in Probate Court. See additional deed recorded herewith for other grantors. The above cited consideration is the same for both deeds and shall be divided between the Grantors.

This is the identical property conveyed to Marshall A. Pickens and Mary Lou T. Pickens by deed of Merlin D. Pickens, et al on 2/9/73 and recorded in the office of the RMC for Greenville County, S. C. in Deed Book 967, page 77.

IT IS HERBBY UNDERSTOOD THAT THIS MORTGAGE CONSTITUTES A VALID SECOND LIEN ON THE ABOVE DESCRIBED PROPERTY.

TOSETHER with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular the said Premises unto the said mortgagee, its (his) successors, heirs and assigns forever.

AND I (we) do hereby bind my (our) self and my (our) heirs, executors and administrators, to procure or execute any further necessary assurances of title to the said premises, the title to which is unencumbered, and also to warrant and forever defend all and singular the said Premises unto the said mortgagee its (his) heirs, successors and assigns, from and against all persons lawfully claiming, or to claim the same or any part thereof.

AND IT IS AGREED, by and between the parties nereto, that the said mortgagor(s) his (their) heirs, executors, or administrators, shall keep the buildings on said premises, insured against loss or damage by fire, for the benefit of the said mortgages, for an amount not less than the unpaid balance on the said Note in such company as shall be approved by the said mortgages, and in default thereof, the said mortgages, its (his) heirs, successors or assigns, may effect such insurance and reimburse themselves under this mortgage for the expense thereof, with interest thereon, from the date of its payment. And it is further agreed that the said mortgages its (his) heirs, successors or assigns shall be entitled to receive from the insurance moneys to be paid, a sum equal to the amount of the debt secured by this mortgage.

AND IT IS AGREED, by and between the said parties, that if the said mortgagor(s), his (their) heirs, executors, administrators or assigns, shall fail to pay all taxes and assessments upon the said premises when the same shall first become payable, then the said mortgages, its (his) heirs, successors or assigns, may cause the same to be paid, together with all penalities and costs incurred thereon, and reimburse themselves under this mortgage for the sums so paid, with interest thereon, from the dates of such payments.

AND IT IS AGREED, by and between the said parties, that upon any default being made in the payment of the said Note, when the same shall become payable, or in any other of the provisions of this mortgage, that then the entire amount of the debt secured, or intended to be secured bereby, shall forthwith become due, at the option of the said mortgages, its (his) heirs, successors or assigns, although the period for the payment of the said debt may not then have expired.

AND IT IS FURTHER AGREED, by and between the said parties, that should legal proceedings be instituted for the foreclosure of this mortgage, or for any purpose involving this mortgage, or should the debt hereby secured be placed in the hands of an attorney at law for collection, by suit or otherwise, that all costs and expenses incurred by the mortgages, its (his) hairs, successors or assigns, including a reasonable counsel fee (of not less than ten per cent of the amount involved) shall thereupon become due and payable as a part of the debt secured hereby, and may be recovered and collected hereunder.

PROVIDED, ALWAYS, and it is the true intent and meaning of the parties to these Presents, that when the said mortgagor, his (their) heirs, executors or administrators shall pay, or cause to be paid unto the said mortgagee, its (his) heirs, successors or assigns, the said debt, with the interest thereon, if any shall be due, and also all sums of money paid by the said mortgages, his (their) heirs, successors, or assigns, according to the conditions and agreements of the said note, and of this mortgage and shall perform all the obligations according to the true intent and meaning of the said note and mortgage, then this Deed of Bargain and Sale shall cease, determine and be void, otherwise it shall remain in full force and virtue,

AND IT IS LASTLY AGREED, by and between the said parties, that the said mortgagor may hold and enjoy the said premises until default of payment shall be made.
