NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that certain piece, parcel or lot of land, situate, lying and being on the southwestern side of Ebaugh Avenue, in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot 132 on a plat of Block "G", East Park (part of Boyce Addition), recorded in the RMC Office, Greenville County, South Carolina in Plat Book A, at Page 383, reference to said plat being craved for a complete and detailed description thereof. Said plat being made a part hereof and incorporated herein by reference. Said Lot fronts 50 feet on the southwestern side of Ebaugh Avenue; runs to a depth of 175 feet on its western boundary line; runs to a depth of 111.5 feet on its eastern boundary line; and is 80.8 feet across the rear. *This being the same property acquired by the mortgagor herein by deed from Edward P. Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever. The Mortgagor covenants and agrees as follows:

Privilege is reserved to pay the debt in whole, or in an amount equal to one or more monthly payments on the principal that are next due on the note, on the first day of any month prior to maturity; *provided, however,* that written notice of an intention to exercise such privilege is given at least thirty (30) days prior to prepayment.
