

OF Dudley and Tea Williams Estates according to survey and plat by John A. Simmons, Registered Surveyor, dated April 24, 1964, recorded in Plat Book 49 at page 664 in the RMC Office for Spartanburg County.

This being the same property conveyed to Mortgagee by Deed of Janet D.
