EARL PATTERSON SHEDD and MADELYN M. SHEDD

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Thirteen Thousand One Hundred Twenty Five and No/100----- DOLLARS (\$ 13,125.00), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

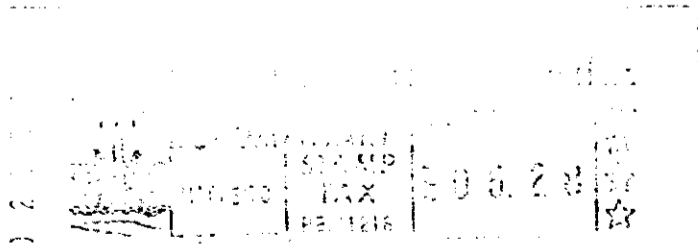
WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable,

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the eastern side of RED OAK COURT, in the County of Greenville, State of South Carolina, being shown as Lot No. 100 on a plat of HOLLY TREE PLANTATION, Phase II, Section III, dated August 17, 1977 prepared by Piedmont Engineers & Architects, recorded in Plat Book 6-H, at page 10 in the RMC Office for Greenville County and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Red Oak Court at the joint front corner of Lot 100 and 101 and running thence with Lot 100 N 45-33 E 177.84 feet to an iron pin at the joint rear corner of Lot 100 and Lot 101; thence S 12-53 E 25 feet to an iron pin; thence S 12-45 E 225 feet to an iron pin at the joint rear corner of Lot 99 and Lot 100; thence with Lot 99 N 66-14 W 168.16 feet to an iron pin on the eastern side of Red Oak Court; thence with said court N 10-80 E 15 feet to an iron pin; thence still with said court N 30-53 W 35 feet to an iron pin; thence still with said court, N 62-38 W 14.6 feet to the point of beginning.

The above described property is the same conveyed to the mortgagors herein by deed of Franklin Enterprises, Inc., dated May 12, 1978, and recorded May 15, 1978, in the RMC Office for Greenville County, S. C., in Deed Book 1079, Page 136.
