

, a corporation organized and existing under the laws of the State of South Carolina , hereirafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Thirty-Six Thousand Nine Hundred Fifty and -Dollars (\$ 36,950.00), with interest from date at the rate of No/100----eight & three-fourthser centum (8-3/4%) per annum until paid, said principal and interest being payable at the office of Carolina National Hortgage Investment Co., Inc., P. O. Box 10636 , or at such other place as the holder of the note may in Charleston, S. C. 29411 designate in writing delivered or mailed to the Mortgagor, in monthly installments of Two Hundred Ninety), commencing on the first day of ----- Dollars (\$ 290.80 and 80/100-----, 19 78, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of June

Now, Know All Men, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of Greenville State of South Carolina;

ALL that piece, parcel or lot of land in the County of Greenville, State of South Carolina, situate, lying and being on the northwestern side of Nottingham Road and being known and designated as Lot No. 192 on a plat of SHERWOOD FOREST Subdivision recorded in the RMC Office for Greenville County in Plat Book GG at Pages 70 and 71 and having such metes and bounds as shown thereon, reference to said plat being made for a more complete description.

THIS is the same property as that conveyed to the Mortgagors herein by deed from the Administrator of Veteran's Affairs recorded in the RMC Office for Greenville County on May 16, 1978.
