NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3,00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

'All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as Lots 7 and 8 of Block G on plat of Stone Estates, recorded in Plat Book G at page 292 and having the following courses and distances:

BEGINNING at an iron pin on the easterly side of Wilshire Drive at a point 151,2 feet north of the northeast corner of the intersection of Wilshire Drive and Reid Street, joint front corner of Lots 6 and 7 and thence along the joint lines of said lots. S. 78-38 E. 149.6 feet to an Iron pin; thence N. 9-30 E. 50 feet to an Iron pin, joint rear corner of Lots 8 and 9; thence along the joint line of Lots 8 and 9, N. 78-38 W. 148.8 feet to an iron pin on the easterly side of Wilshire Drive; thonce along the easterly side of Wilshire Drive, S. 11-22 W. 50 feet to the point of beginning.

The estimated monthly premium for the first nine years will be ,02% of the original amount of the loan.
