with interest thereon from date at the rate of 8 1/2 per centum per annum, to be paid: Yearly

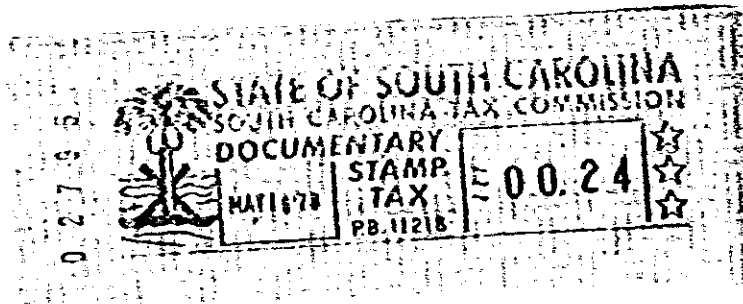
WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, about one mile northwest of Greer, S.C. lying on the eastern side of the Jones Road, and being the same lot conveyed to us on the 2nd day of April 1977 by deed, from Lloyd E. Hunt, and having the following courses and distances.

Beginning at a point in the center of the said Road, joint corner of the Earnest Williams lot, and runs thence with the Jones Road N. 9-30 W. 96 feet to a point in the said Road, joint corner of the lot now or formerly of Mabry; thence with the Mabry lot line N. 79-10 E. 224 feet to an iron pin on the Caldwell line; thence with the said line S. 2-44 W. 197.5 feet to an iron pin, the common corner of this lot and the Earnest Williams lot; thence with the Williams lot line N. 89-24 W. 197.5 feet to the beginning corner.

This being the same property as conveyed to the Mortgagor by deed of Lloyd E. Hunt and being recorded in R.M.C. Office for Greenville County on April 5, 1977.
