NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being on the Northern side of Sir Abbott Street, being shown and designated as Lot No. 90 on a Plat of SHERWOOD FOREST made by Dalton & Neves, Engineers, dated August, 1951, revised through November 1962, recorded in the RMC Office for Greenville County, South Carolina in Plat Book GG, Pages 1 and 2, and having according to said Plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northern side of Sir Abbott Street at the joint front corners of Lots Nos. 89 and 90 and running thence with the line of Lot No. 89, N. 27-14 W., 169.3 feet to an iron pin; thence N. 60-01 E., 75.09 feet to an iron pin; thence with the line of Lot No. 91, S. 27-14 E., 172.9 feet to an iron pin on the Northern side of Sir Abbott Street; thence with the Northern side of Sir Abbott Street, S. 62-46 W., 75 feet to an iron pin, the beginning corner.

In addition to and together with the monthly payments of principal and interest under the terms of the Note secured hereby, the mortgagor promises to pay to the mortgagee a monthly premium necessary to carry private mortgage guaranty insurance until the principal balance reaches 80% of the original sales price or appraisal, whichever is less. The estimated monthly premium for the first nine years will be .02% of the original amount of the loan. The estimated monthly premium for each year thereafter will be .01% of the original principal balance of this loan.
