with interest thereon from said date at the rate of 1 per centum per annum, to be paid: semi-monthly

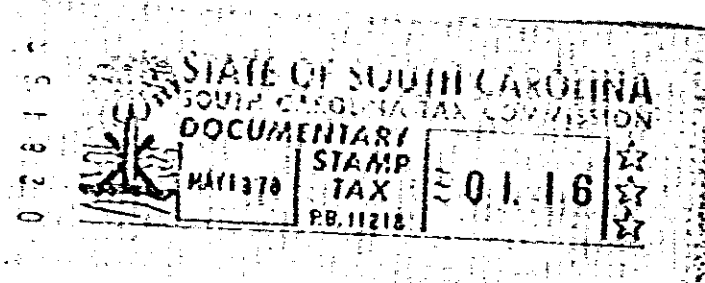
