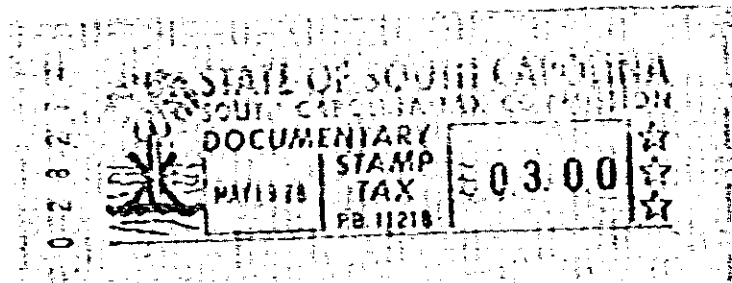

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville on the western side of Augusta Road and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Augusta Road, said iron pin being the joint front corner of the property now or formerly belonging to Davig G. Traxler and running thence along said Road, N. 1-02 W. 75 feet to a point; thence in a southwesterly direction 454 feet more or less to a point on the western boundary of property herein described and property now or formerly belonging to William Ed Delisk; thence, S. 28-08 E. 60 feet to corner of property now or formerly belonging to David G. Traxler; thence, N. 70-23 E. 416.2 feet more or less to an iron pin, point of Beginning. (The second course and distance is S. 68-37 W. 451.79 feet)
