with interest thereon from date at the rate of 8% per centum per annum, to be paid: ANNUALLY

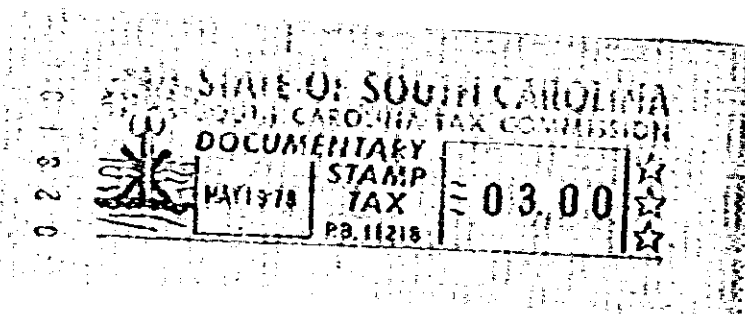

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, South Carolina, near the town of Mauldin, South Carolina on Baldwin Road, and being shown and designated as Tract No. 2, on a plat entitled "Property of Roy C. Cunningham", prepared by Gould & Associates, Surveyors, dated September 23, 1977, and recorded in the RMC Office for Greenville County, S. C. in Plat Book 5-W at page 12, and having according to said plat such metes and bounds as shown thereon, reference is hereby made to said plat for a more particular description.

This being the same property conveyed to the Mortgagor by Deed of Roy C. Cunningham, of even date to be recorded herewith.

The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
