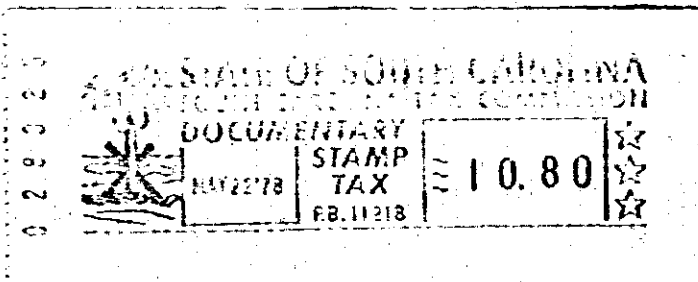

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in O'Neal Township, located on Pennington Road approximately seven (7) miles north of the City of Greer and having, according to a plat of the property of Lloyd E. Hunt, dated June 15, 1968, by H. S. Brockman, the following metes and bounds, to-wit:

BEGINNING at a point in the center of Pennington Road at the corner of property now or formerly of Maggie M. Caldwell, and running thence along said road N 16-00 W 76 feet; N 0-30 W 462 feet; N 6-30 E 257.1 feet; thence leaving said road S 84-46 W 295 feet; thence N 1-06 E 150 feet; thence N 17-00 W 140 feet, more or less, thence S 82-00 W 105 feet; thence N 9-30 W 163 feet to the line of property now or formerly owned by Finley; thence S 84-00 W 378 feet; thence 69-00 W 198 feet; thence S 21-30 E 1215.5 feet; thence N 84-30 E 568.1 feet to the center of Pennington Road, the beginning point.
