NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being shown and designated as Lot No. 118 on plat entitled "Map No. 5, Sugar Creek" as recorded in the RMC Office for Greenville County, SC in Plat Book 6-H at Page 2, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeasterly side of Sun Meadow Road, said pin being the joint front corner of Lots 117 and 118 and running thence with the common line of said lots, S 46-48-38 E 164.56 feet to an iron pin, joint rear corner of Lots 117 and 118; thence, N 45-16-51 E 125.08 feet to an iron pin, joint rear corner of Lots 118 & 119; thence with the common line of said lots, N 46-48-38 W 169.13 feet to an iron pin on the southeasterly side of Sun Meadow Road; thence with the southeasterly side of said Road, S 42-22-21 W 125 feet to an iron pin, the point of beginning.
