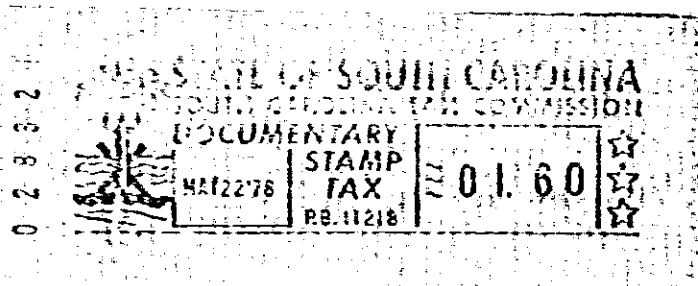
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Gantt Township, on Kondros Circle, containing one acre, and being more fully described as follows according to plat entitled Survey For Harry Sherman and Gail Adams, prepared by Enwright Associates Inc., on April 19, 1978, which plat is recorded in the R. M. O. Office for Greenville County in Plat BOOK 6P at page 38 :

BEGINNING at an iron pin on Kondros Circle, joint corner with property of Ernest Aberorombie et al, and running thence with the line of Aberorombie, S. 79-43'-30" E. 278.33 feet to iron pin; thence with other property of the grantor herein, S. 14-00 W. 165.88 feet to iron pin; thence with other property of the grantor herein, N. 76-00 W. 277.74 feet to iron pin on Kondros Circle; thence with Kondros Circle N. 14-00 E. 147.80 feet to the beginning corner.

The above described property is the same conveyed to the mortgagors by the mortgagee by deed dated this date and to be recorded herewith.
