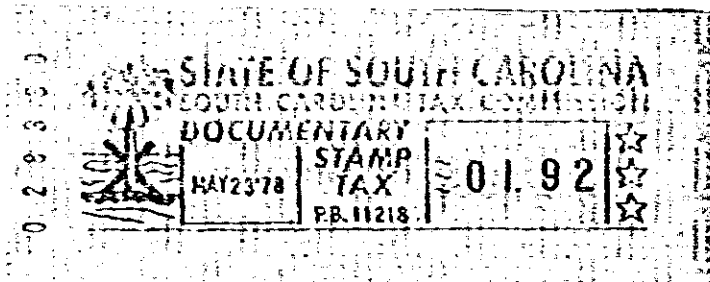

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Monagham Mills Village, and being more particularly described as Lot No. 46, Section 1, as shown on a plat entitled "Addition to Subdivision of Victor-Monagham Mills, Greenville, S. C.", made by Pickell & Pickell, Engineers, December 20, 1948 and recorded in the RMC Office for Greenville County in Plat Book S at Page 178, and having such metes and bounds as shown thereon, reference to said plat being made for a more complete description; said lot situate, lying and being on Smythe Street.
