MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: Venus N. Epting

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of **Twenty-seven Thousand and no/100ths** DOLLARS

(\$ 27,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is **thirty (30)** years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

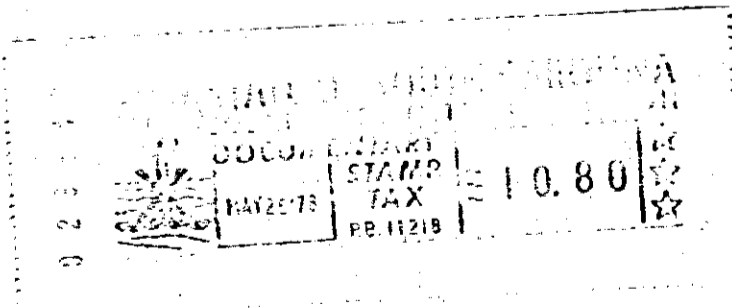
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, in the City of Greenville, being known and designated as Lot 60 of Block F as shown on plat of University Heights recorded in Plat Book, BB at page 21, described as follows:

BEGINNING at an iron pin at the northeastern intersection of Carmel Street and Corrine Drive, and running thence with said Carmel Street, N. 56-37 E. 95.5 feet to an iron pin, corner of Lot 61; thence with the line of said lot, N. 31-12 W. 190.2 feet to an iron pin in the line of Lot 65; thence with the line of said lot, S. 56-37 W. 95.5 feet to an iron pin on the eastern side of Corrine Drive; thence with said drive, S. 31-13 E. 190 feet to the point of beginning.
