with interest thereon from date at the rate of eight per centum per annum, said principal and interest to be repaid: within one year from date.

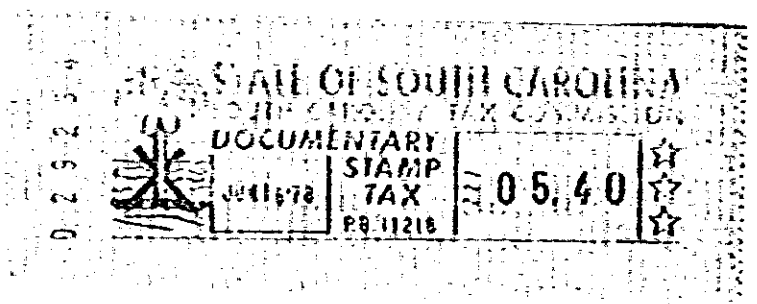
