MORTGAGE

STATE OF SOUTH CAROLINA
COUNTY OF GREENVILLE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

Angela Elaine Bolt and Joe F. Smith
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty Four Thousand and no/100----- DOLLARS

(\$ 24,000.00-----), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is thirty years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

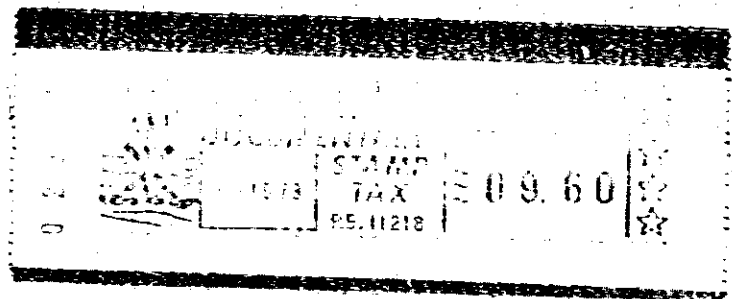
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as Lot 128 on plat of Riverdale, recorded in Plat Book KK at page 107 and having the following courses and distances:

BEGINNING at an iron pin on Riverview Drive, joint front corner of Lots 128 and 129 and running thence with the joint line of said lots, S. 16-51 W. 216.9 feet to an iron pin, joint rear corner of said lots; thence along the rear line of Lot 128, N. 76-01 W. 100.06 feet to an iron pin, joint rear corner of Lots 127 and 128; thence with the joint line of said lots, N. 16-51 E. 221.9 feet to an iron pin on Riverview Drive; thence with said Drive, S. 73-09 E. 100 feet to an iron pin, the point of beginning.

Being the same property conveyed to Angela Elaine Bolt by Parker Chapman by deed recorded April 21, 1978 and an undivided-one-half interest conveyed by Angela Elaine Bolt to Joe F. Smith by deed recorded herewith.



Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
