with interest thereon from DATE at the rate of EIGHT(8) per centum per annum, to be paid: QUARTERLY.

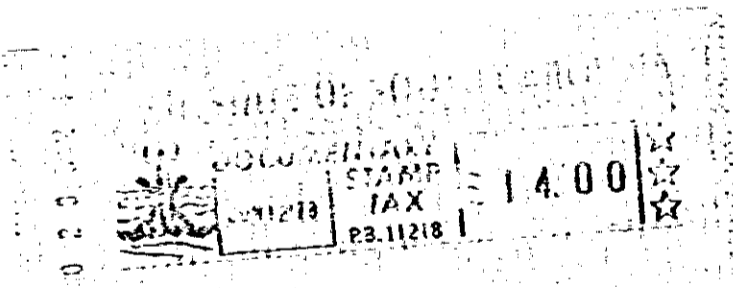

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, containing one (1) acre more or less, as shown on a plat of Property of Joel E. and Karen H. Maddox, prepared by C. O. Riddle, RLS, on April 8, 1977, and having according thereto the following courses and distances:

BEGINNING at an old iron pin on the Northern side of Pine Drive at the Gunter corner, and running thence N. 12-25 E. 318 feet to an iron pin; thence along a new line S. 46-39 E. 326.7 feet to an iron pin on Pine Drive; thence along said Drive S. 83-04 W. 15 feet to an old iron pin; thence along said Drive S. 76-13 W. 100 feet to an old iron pin; thence along said Drive S. 72-40 W. 203.2 feet to the beginning corner.
