TO ALL WHOM THESE PRESENTS MAY CONCERN:

JAMES BRUCE BROWN, SR. and MAMIE LEE BROWN

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of -----
Twelve Thousand Five Hundred and No/100----- DOLLARS

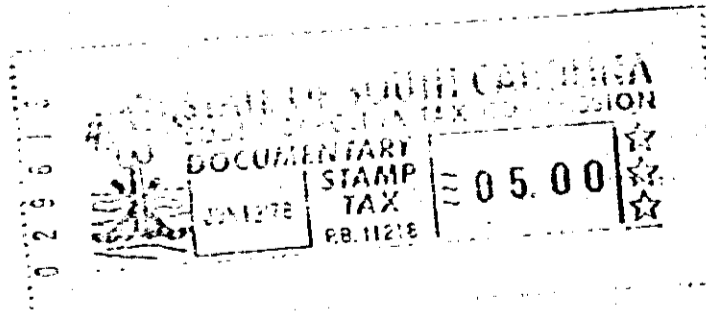
All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, located on the southern side of East Perry Road, and being shown and designated as Lot No. 2 on a plat entitled "LEAWOOD HILLS" made for E. H. Batson and Homer Styles by Terry T. Dill, Surveyor, dated October 1958, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of East Perry Road at the joint front corner of Lots 1 and 2 and running thence with the line of Lot 1, S 46-38 E 112.2 feet to an iron pin on the property line now or formerly of Nell Ward; thence with the line of said property N 43-30 E 100 feet to an iron pin at the joint rear corner of Lot 3; thence with the line of said lot, N 46-38 W 112.4 feet to an iron pin on the southern side of East Perry Road; thence with the southern side of East Perry Road S 43-22 W 100 feet to the point of beginning.
