TO ALL WHOM THESE PRESENTS MAY CONCERN: JERRY D. ESKEW & MYRA J. ESKEW

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of FIFTY TWO THOUSAND FOUR HUNDRED ----- DOLLARS

(\$ 52,400.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 30 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southwestern side of Hiawatha Drive, being shown as Lot No. 222 on plat of Sector V, Botany Woods, recorded in Plat Book YY at pages 6 & 7, and described as follows:

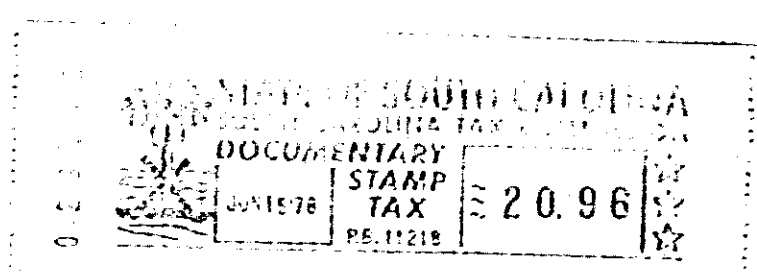
Beginning at an iron pin on the southwest side of Hiawatha Drive, at the joint front corner of Lot Nos. 222 and 223, and running thence with the line of said lots, S. 32-20 W. 191.7 feet to an iron pin; thence N. 54-39 W. 90 feet to pin rear corner of lot No. 221; thence with the line of Lot No. 221, N. 29-32 E. 198 feet to pin on Hiawatha Drive; thence with the southwest side of Hiawatha Drive, S. 51-15 E. 100 feet to the point of beginning.

This is the same lot conveyed to mortgagors by Norman T. & Patricia H. Greiner by deed of even date herewith to be recorded.

"In addition to and together with the monthly payments of principal and interest under the terms of the Note secured hereby, the mortgagor promises to pay to the mortgagee a monthly premium necessary to carry private mortgage guaranty insurance until the principal balance reaches 80% of the original sales price or appraisal, whichever is less. The estimated monthly premium for the first nine years will be .02% of the original amount of the loan. The estimated monthly premium for each year thereafter will be .01% of the original principal balance of this loan. The mortgagee may advance this premium and collect it as part of the debt secured by the mortgage if the mortgagor fails to pay it."
