WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty Two Thousand Five Hundred and 00/100 -----DOLLARS

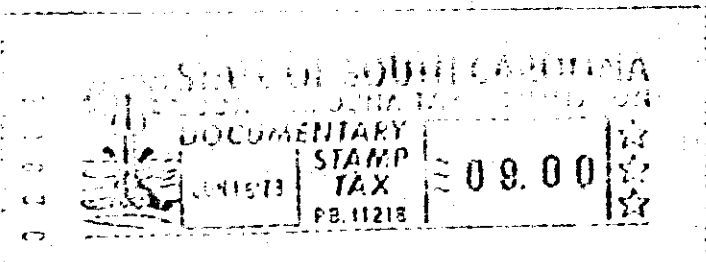
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Gantt Township, on the western side of Brantford Lane, and being known and designated as Lot No. 73 according to a plat entitled "South Forest Estates" prepared by Pickell & Pickell Engineers, dated August 29, 1955, and recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book GG at Page 181, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Brantford Lane at the joint front corner of Lots Nos. 73 and 74 and running thence with the common line of said lots, S. 66-34 W. 130 feet to an iron pin; thence N. 20-55 W. 65.3 feet to an iron pin; thence N. 7-54 W. 59.5 feet to an iron pin at the joint rear corner of Lots Nos. 72 and 73; thence running with the common line of said lots, N. 84-41 W. 122.2 feet to an iron pin on the western side of Brantford Lane; thence running thence with the western side of Brantford Lane, S. 14-15 E. 31.6 feet; thence continuing with Brantford Lane, S. 23-26 E. 53.4 feet to the point of beginning.

The above described property is the same acquired by the Mortgagors by deed from John P. Underwood and Frances E. Underwood recorded in the R.M.C. Office for Greenville County, S. C. on June 16, 1978.
