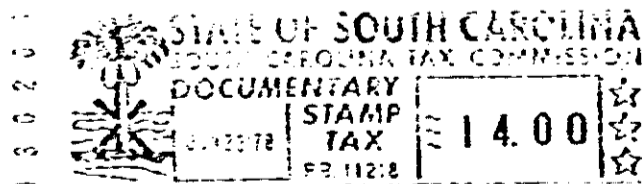

~~ALL THAT PIECE, PARCEL OR LOT OF LAND, LYING AND BEING ON THE WESTERN SIDE OF MOUNT VERE DRIVE IN THE COUNTY OF GREENVILLE, STATE OF SOUTH CAROLINA BEING SHOWN AND DESIGNATED AS LOT NO. 4 ON A PLAT ENTITLED "PROPERTY OF ROBERT S. SMALL" PREPARED BY ENWRIGHT ASSOCIATES, ENGINEERS AND DATED JULY 27, 1972, REVISED JULY 12, 1973, RECORDED IN THE R.M.C. OFFICE FOR GREENVILLE COUNTY IN PLAT BOOK 4-X AT PAGE 67 AND HAVING, ACCORDING TO SAID PLAT, THE FOLLOWING METES AND BOUNDS, TO-WIT:~~

All that piece, parcel or lot of land situate, lying and being on the western side of Mount Vere Drive in the County of Greenville, State of South Carolina being shown and designated as Lot No. 4 on a plat entitled "Property of Robert S. Small" prepared by Enwright Associates, Engineers and dated July 27, 1972, revised July 12, 1973, recorded in the R.M.C. Office for Greenville County in Plat Book 4-X at Page 67 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Mount Vere Drive at the joint front corner of Lots Nos. 3 and 4 and running thence with the line of Lot No. 3 S. 66-51 W. 245.5 feet to an iron pin at the joint rear corner of Lots Nos. 3 and 4; thence N. 23-02 W. 150 feet to an iron pin at the joint rear corner of Lots Nos. 4 and 5; thence with the line of Lot No. 5 N. 66-51 E. 249.7 feet to an iron pin on the western side of Mount Vere Drive; thence with the western side of Mount Vere Drive S. 22-58 E. 150 feet to the point of beginning.
