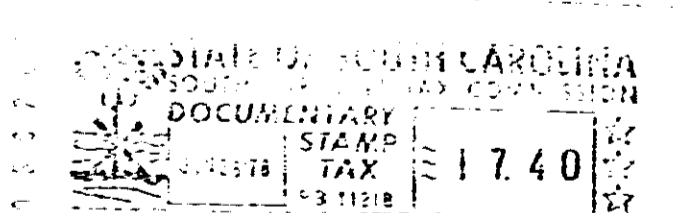
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 25, Carter's Grove, as shown on plat thereof prepared by Dalton & Neves, dated August, 1974, and recorded in the RMC Office for Greenville County, S. C. in Plat Book 4R, at Page 99, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Foxcroft Road, joint front corner of Lots 24 and 25, and running thence with the common line of said two lots, N. 81-17 W. 160.1 feet to an iron pin in the line of Lot 17; thence with the side lot line of Lot 17 and the rear line of Lot 25, N. 7-35 E. 97.9 feet to an iron pin; thence S. 80-05 E. 165 feet to an iron pin on the western side of Foxcroft Road; thence with the western side of Foxcroft Road S. 10-31 W. 94.5 feet to the point of beginning.
