TO ALL WHOM THESE PRESENTS MAY CONCERN: EDWARD F. SCHAACK AND

MARY H. SCHAACK (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of FIFTY THOUSAND AND NO/100 ----- DOLLARS

(\$ 50,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is twenty nine years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

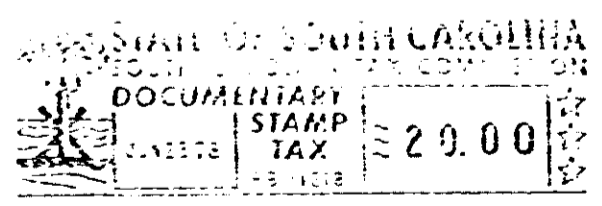

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, known and designated as Lot No. 28, Plantation Drive, on a plat of Holly Tree Plantation, Phase II, Section II, prepared by Piedmont Engineers and Architects, dated January 10, 1974 and recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book 5-D at page 47, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint front corner of Lots 27 and 28 on Pecan Hill Drive and running thence with Pecan Hill Drive N. 4-34 E. 13.47 feet to an iron pin; thence N. 15-09 E. 44.25 feet to an iron pin; thence N. 24-21 E. 44.20 feet to an iron pin; thence N. 31-16 E. 43.18 feet to an iron pin; thence N. 37-03 E. 49.90 feet to an iron pin thence N. 82-48 E. 34.95 feet to an iron pin on Plantation Drive; thence with Plantation Drive S. 51-27 E. 49.95 feet to an iron pin; thence S. 60-54 E. 50 feet to an iron pin; thence S. 68-56 E. 5 feet to an iron pin at the joint corners of Lots 28 and 29; thence with the said lot line S. 15-39 W. 131.20 feet to an iron pin at the joint rear corners of Lots 28 and 27; thence with said lot line N. 88-00 W. 170 feet to the point of beginning.
