(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of FORTY FIVE THOUSAND AND NO/100 -----DOLLARS

(\$ 45,000.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 30 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

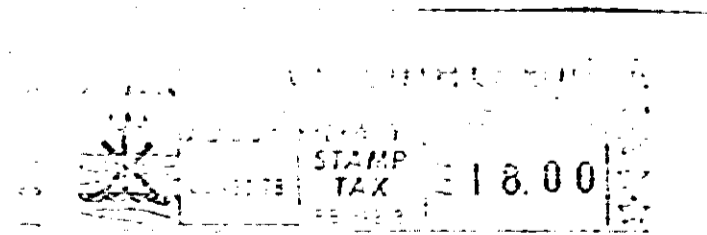
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 105 on a plat of Sugar Creek Subdivision, Map #5 prepared by C.O. Riddle, Surveyor dated June 8, 1977 recorded in the RMC Office for Greenville County in Plat Book 6H at Page 2 and having according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the southeastern edge of Briar Creek Road at the joint front corner of Lots 105 and 106 and running thence with the edge of Briar Creek Road, S. 45-00 W., 105 feet to an iron pin at the joint front corner of Lots 104 and 105; thence with the joint line of said lots, S. 45-00 E., 179.55 feet to an iron pin at the joint rear corner of Lots 104 and 105; thence along the rear line of Lot 105, N. 38-42-43 E., 105.64 feet to an iron pin at the joint rear corner of Lots 105 and 106; thence with the joint line of said lots, N. 45-00 W., 167.98 feet to an iron pin being the point of beginning.

This is the same property conveyed to the mortgagors by Deed of Cothran and Darby Builders, Inc. recorded June 30, 1978 in Deed Book 1082 at Page 302, RMC Office for Greenville County.
