TO ALL WHOM THESE PRESENTS MAY CONCERN: Donna M. Floyd

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Associates Financial Services Co Inc (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Fifteen Thousand Five Hundred Fifty-two & no/100 DOLLARS (\$ 15,552.00), with interest thereon from date at the rate of maturity at nine / per centum per annum, said principal and interest to be repaid:

in 72 equal monthly installments of \$216.00 each, the first of said installments being due August 21, 1978 and a like installment due on the same day of each month thereafter until paid in full.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Helen Drive in Gantt Township, being shown and designated as Lot Number 180 on plat of Rockvale, Section 2, recorded in Plat Book QQ at Page 109 of the RMC Office for Greenville County.
