AS SET FORTH IN SAID NOTE,

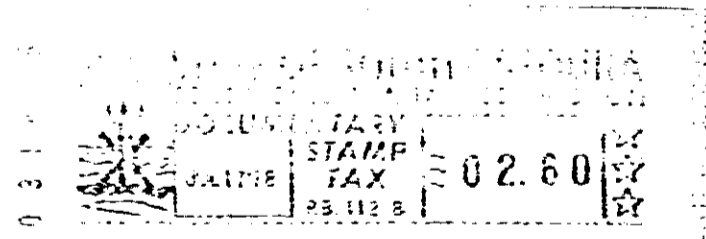
with interest thereon from DATE at the rate of EIGHT per centum per annum, to be paid: MONTHLY,

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

*ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, consisting of two (2) lots, designated as Lot Nos. 43 and 44, Block 1 of Newlands Subdivision, recorded in Plat Book C at Page 199, having a width of 100 feet on the Northwest side of Burgess Avenue, and a depth of 150 feet, with courses shown on said plat.
